Raymond James presents and recommends taking \$5mil from Seizert and \$5mil from cash and put into an index fund because the fund needs more exposure to large cap stocks.

**A. SECURITIES LITIGATION REPORT**

Marisa DeMato and Frank McConville, Labaton Sucharow LLP, presents

Began monitoring in Feb 2016. Moved to half-yearly reporting. The report shows the fund's losses tied to actual securities fraud cases as well as settlements. One main case in first half of 2020 that P&F had a meaningful loss. There should be a ruling before the end of 2020. Will keep the fund posted. Not able to produce the requested report Jerry Sagnella requested, but the fund custodian receives the checks the fund earns back from the cases.

**B. UPDATE ON PAYMENT OF ADMINISTRATIVE EXPENSES  
(INFORMATION ONLY)**

Carolyn Kone and Hooker and Holcombe representatives discuss the estimated administrative expenses of the fund are included in the ADEC. H&H conducts a bi-annual Valuation Report. The Finance Dept has it as part of the GASBY audit. There is an inflation factor. Those included in the administrative expenses are ADR (fee charged by custodial banks by international equities), BSW, First State, H&H, Morgan Stanley/Raymond James, Northern Trust, Yale Occupational. There is a follow-up meeting to include Corp Counsel next week. Carolyn Kone plans to come back in October with a possible recommendation.

**C. PENSION PORTAL (INFORMATION ONLY)**

Re: Limit per employee per year & length of time prior to retirement date

Leanna Ambersley discusses the online pension estimate portal through the actuary, H&H. Employees will have no limit on the number of estimates. It is suggested there be a limit on the amount of official retirement calculations an employee can request per year, as well as a specific timeframe the official request can be made prior to a retirement date. The pension staff, due to how it is currently handled, time and effort put into the official calculations, and from talks with the actuary, suggest two or three official calculations per year, per person, and the official calculation has to be two months or less prior to the retirement date. Changes to the caps can be made in the future. The CERF board agreed and acknowledged as well.

The Pension Board shall have the sole discretion to waive the provisions of (S), (1), (2) and (3) of the Elm City Local police union contractual pension provisions, upon certification by the Chief that the disability was service-connected and occurred while the employee was affecting an arrest, while participating in departmental training, while responding to calls for Police Service or while handling calls for Police Service of a hazardous nature. In such case, the disability pension shall not be subject to such cap on earnings nor to any cost of living increase.
