**ITEM 3: ADMINISTRATIVE MATTERS:**

**A. UPDATE ON CONTRACTS WITH RAYMOND JAMES**

Fund Counsel, Carolyn Kone updates the Trustees that she is reviewing the contracts with Raymond James. She will be meeting with Trustee Sagnella on Friday to discuss further. One issue she came across was that First State Trust cannot serve as co-custodian bank with the transfer to Raymond James. Derek Ciampini explained that is not true, he spoke with Helen Garvine yesterday and she stated that was not the case. Carolyn Kone requests either a Special Meeting or a telephonic meeting on December 30<sup>th</sup> with the Trustees.

**B. STATUS OF LEGAL COUNSEL CONTRACT**

Trustee Sagnella updates the Trustees that the legal counsel contract was sent to Corp Counsel to review.

**C. (CERF) LEGAL COUNSEL DISCUSSION ABOUT THE BOARD'S RECOMMENDATION TO LABOR RELATIONS TO HAVE EMPLOYEES AGE 60 AND ABOVE TO HAVE THE OPTION TO JOIN PENSION PLAN OR SOCIAL SECURITY OR BE ENTITLED TO RETURN OF CONTRIBUTIONS WITH INTEREST IF EMPLOYED LESS THAN 10 YEARS.**

Carolyn Kone explains: CT Law age discrimination is prohibited whether young or old. She is worried this could create a lawsuit if granted to those employees over the age of 60 and not to those under the age of 60 (in reference to return of contributions with interest if employed less than 10 years). Further research would need to be done to see if there is an exception in the CT Law for pension plans.

**D. (CERF) POTENTIAL EMPLOYEE PRIOR SERVICE BUYBACK FOR PRIOR SPECIAL FUNDS EMPLOYEES**

Harold Brooks presents. There are fifteen members of Local 3144 and three or four members of Local 884 who have continuous service with the City of New Haven as Special Fund Employees and now General Fund Employees who would like the option to buyback their time while they were a Special Fund employee. The unions would like the Trustees to endorse the buyback option for current employees. They request a recommendation to Labor Relations and an actuarial study of how the fund would be impacted. Trustee Mayor Harp states the unions should pay for the actuarial study, not the pension funds. Also, they will need to gather a list from all the unions of the employees looking to buyback this time. Trustee Jones encourages the union membership to participate in the monthly pension meetings.
