RE: TRAFFIC SIGNAL SYSTEM, Authorization for Mayor to enter into Agreement with the State of Connecticut to obtain Federal Funding for the Construction, Inspection and Maintenance of 18 Traffic Signals (Director of Transportation, Traffic & Parking).

BACKGROUND

Before the Board is an Agreement between the State of Connecticut and the City for the construction, inspection and maintenance related to the modernization of the City's traffic control system at 18 intersection locations within the City. Federal funding through the State is available under the Congestion Mitigation and Air Quality Improvement Program to replace traffic signals, thus relieving congestion and improving air quality as a benefit to the City.

PLANNING CONSIDERATIONS

The State has agreed to fund the total construction cost of \$4,200,000 for this project. Through various State and Federal programs, the City has been working towards upgrading signals across the City, some as result of development projects and major construction activities. The new signals will include exclusive pedestrian walk phases, new crosswalks and emergency vehicle preemption system equipment at the following intersections:
