No comments were provided. Upon a motion by Commissioner Abbagnaro, seconded by Commissioner Punzo, the minutes of the October 6, 2022 Regular Meeting and the October 24, 2022 Special Meeting were unanimously approved by all Commissioners present at the meeting.

- **7. Election of Vice-Chair.** Commissioner Abbagnaro moved to elect Commissioner Punzo to the position of Vice-Chair. Commissioner Zinn seconded the motion and Commissioner Punzo was elected to the position of Vice-Chair by unanimous vote of all commissioners present at the meeting.
- **8. December Board Meeting Date.** Because the Executive Director will be attending a conference on the first Thursday of December 2022 the Board discussed moving the meeting date. After discussion, the Commissioners present decided to move the meeting date by one week to 5:30 p.m. on December

8, 2022. At this time, the Commissioners discussed a potential change to the regular meeting date and time to be implemented if desired by the Commissioners. The NHPA By-Laws currently state that the meetings will be held on the first Thursday of each month, so that prior to changing the regular meeting day, the Board must first vote to amend the By-laws.

**6. Parcels 1,4,5,6** – The Board discussed these proposed port area purchases and the necessary next steps and path forward for making the purchases. Chairman Abbagnaro spoke in favor of purchasing the parcels and moved to approve the purchase. The motion was seconded by Commissioner Fabiani and passed unanimously.

New Haven Marine Group/New Haven Harbor CoOp – The CoOp Equipment Deployment Drill was held at the Canal Dock Boathouse with participation from the USCG, DEEP and NHFD.
