Site Plan Review, Coastal Site Plan Review, and Inland Wetlands Review

Modifications to a site plan to increase expansion of parking at Tweed Airport from 203 to 237 new spaces, in the Coastal Management Area and Airport Zone, with activity in the Inland Wetlands Regulated Area.

The Commissioners discussed the Petition for Intervention.

Commissioner Alder Marchand moved to deny the Petition for Intervention at 6:48pm. 5-0 in favor.

Director Brown shared planning considerations on the item and reviewed the technical memo provided by an outside consultant at the Commission's request.

Planner Rose-Wilen stated that the Commission had received 20 items of testimony in opposition to the item including 3 items new since the last hearing.

Attorney Joseph Williams introduced the applicant team and stated that no changes were made to the application since the last meeting.

The Chair opened the floor for public testimony.

Ten members of the public gave testimony, one person in support and nine people in opposition.

Topics raised in public testimony include:

- Support for the application
- Environmental concerns
- Concerns with the airport's zoning violation in doing the work without permits
- Concerns with impacts on the inland wetlands
- Alternatives for parking locations
- Lack of soil erosion and sediment control during construction
- Improper maintenance harming inland wetlands areas
- History of violations/conducting work without permits
- Possibility of using shuttles
- Concerns with traffic
- Whether there is demand for the proposed additional parking
- Whether debris in the inland wetlands had been cleaned up
- Whether an environmental assessment had been completed
- Whether the fence could be located further toward the edge of the Regulated Area
- Concerns about stormwater runoff
- The federal Environmental Assessment in progress for the airport

The applicant team responded to questions raised in public testimony and by the Commissioners.

The Chair closed the floor for testimony at 8:29pm.

- Zoning violations
- That the application meets the relevant regulations
- The larger issue of air travel impacts on the environment (noted as unrelated to the decision before the Commission)
