L9	Do we have attorneys for the police
20	department and for the union here?
21	MR. DUGAS: Attorney Floyd Dugas
22	representing the administration.
23	MR. MENT: Jeffrey Ment, and I'm
24	here with Officer Diaz.
25	CHAIRPERSON RIBEIRO: How do you

4	for this matter to be in open or closed session?
