A. OUTSIDE EARNINGS UPDATE Re: Incomplete applications (Information Only) Leanna Ambersley notified the Trustees that 3 retirees have been inactivated for June for not submitting required documents yet. They will be reactivated and paid retro once they comply.

B. DISCUSSION: OUTSIDE EARNINGS CAP

Leanna Ambersley explained to the Trustees that the current outside earnings cap for those on a disability pension is \$6,800 annually, which was first created in 1984. Several retirees have expressed that this is very low. Leanna Ambersley stated \$6800 from 1984 is equivalent to about \$20,000 today according to a Google conversion calculator. There are also many work-from-home jobs now compared to then. If Trustees were interested possibly either can be negotiated into contracts via unions or changed via MOUs.
