There were 4 five in 2022 and about 27 in the last five years, and 5 three up until now this year. So we are recommending 6 that we approve an All Way Stop. It's currently stop 7 now in the westbound direction. Pine Street is a one 8 way westbound. And we would make north -- putting 9 stop signs for the north and southbound on Blatchley 10 Avenue. We recommend the approval. 11 COMMISSIONER RIBEIRO: Okay. Commissioners, any 12 questions? Okay. Seeing none, what is your 13 pleasure? 14 COMMISSIONER MIRANDA: I make a -- Commissioner 15 Miranda. COMMISSIONER MIRANDA: Aye.

COMMISSIONER RIBEIRO: Opposed? Abstentions? Okay, motion carry.

MR. FISCHER: Item 2 is a request of the department for a change on the section of York Street between South Frontage Road and Martin Luther King Boulevard. It's currently a one way in the northbound direction. And we would like to change it to two ways in that one block. It -- it was previously a one way from Howard Avenue to South Frontage Road. And that segment was changed about a year and a half, two years ago to two ways.

The segment between York Street -- excuse me, South Frontage Road and MLK was not changed because there was no study done on the impact of -- on traffic between -- section between York and MLK.

17 We have subsequently completed a traffic study 18 on the impact that it would have and the necessary 19 single improvement we would have to do. And we would 20 now -- we have confirmation that it would actually 21 rightly help traffic on South Frontage Road to make 22 the section between South Frontage and MLK that will 23 reduce the congestion along South Frontage Road very 24 slightly during the afternoon peak. We would now 25 like to --

If -- if somebody could actually go through 1 2 about 20 pages. If somebody could go report there 3 and change. There's a -- there a drawing for ... Next 4 page I believe. Right here. So what happened is the -- there was -- the 5 6 result, it's right now two lanes heading from South 7 Frontage Road towards north -- towards MLK Boulevard. 8 And it will become -- in the section that's painted 9 slightly yellow, that section will become two ways. 10 The signal at South Frontage and York would be 11 revised to have head spacing in the southbound 12 direction. And this would reduce the traffic that's 13 now going around the block on MLK up to Park Street. 14 It has to go Park Street and turn left onto South 15 Frontage Boulevard. 16 It would traffic to South Frontage which will 17 now just turn left at York Street and head to the 18 emergency room door. And it would actually help 19 traffic operations. 20 So we are asking the Board to -- the Commission 21 here to approve this change. And it would be under 22 construction shortly. 23 COMMISSIONER RIBEIRO: Questions, Commissioners? 24 COMMISSIONER WALKER: How long will it take to 25 complete the necessary --

1	MR. FISCHER: Well, it would probably

3	if you see where that no-right-turn sign is and
4	there's an arrow pointing to that corner, that corner
5	we need to put in a new signal pole. And the
6	construction will probably take two to three months
7	and the wiring, etc., is another few months. So we

FISCHER: There's overriding background 13 things going on here. First of all, it's -- it's 14 part of a -- of a larger plan to convert a number of 15 downtown streets to two way. This is -- this is an 16 overriding concern of the -- the -- the politicians 17 and -- and residents and business owners who have 18 looked to apply this street system. They feel the 19 one-way street system is too complicated. And there 20 lies concerns with making many of the streets 21 converted from one way to two way. 22 The other thing is that there's been a -- the 23 Yale New Haven Hospital administration has been 24 working to make this change. They have been pushing 25 us to do this because they feel it's -- it's better

13	Howard to to to South Frontage, is that a two
14	way now?
15	MR. FISCHER: Yes. It's we've made that way
16	during the construction of the South Frontage Road
17	work that was done in conjunction with the
18	construction of 101 College Street. South Frontage
19	Road was widened. And it was part of the detours,
20	etc. So that the road was made two ways during the
21	construction.

24	hasn't hasn't caused any problems and it's worked
25	out to be helpful. Yale New Haven Hospital is very,

21	warehouse for this storage.
22	They are rearranging their driveway off of
23	Prospect Street. And they are relocating a current
24	driveway. And they are asking us to rearrange
25	parking spaces so that they can get in with tractor

1	trailers off of Prospect Street. And they are asking
2	us to post No Parking for the truck and interfacility
3	without necessarily encroaching on traffic.
4	And you can't actually see the old driveway in
5	this drawing, but the No Parking would be from 150
6	feet south of Prospect Street which you can't see in
7	this drawing. And the spaces that are $Ex'd$ out here
8	will be where they it's the grouping parking. And
9	those spaces would be removed and made No Parking.
10	The driveway is where the green lane is there.
11	You can I guess because of the way the drawing
12	are a little big for the screen here, but where the
13	green line is and it says new 30-foot wide driveway.
14	And you need a little more because of the size of the
15	vehicles that have to turn into this driveway.
16	They'll need they'll need this what's
17	called a turning radiant. They'll need the other
18	so that they don't scratch out or dent any cars that
19	park near there. They re going to need these extra
20	spaces.
21	We will get back some spaces. There are
22	currently no parking. So it's kind of a tradeoff.
23	COMMISSIONER RIBEIRO: Well
24	MR. FISCHER: We are asking you to approve the
25	new signing that will be necessary to do this.

It was really a good night. You know, it -- it was up between Brookside and the Manor. And a lot of people came out so thank you for that, Chief Colon.

Just an update on the violence numbers. Right now we have 42 non-fatal shootings where last year at this time we had 72. So we have a 30 per -- 30 -actual 30 less people have been shot in the category. And then last year at this time we had seven homicides. Right now, we have 14 homicides. So overall 23 less people have been shot in the city.

12 I just wanted to comment on a federal case we 13 took down last week as well. We've been working with 14 our federal partners. Actually all -- all of them 15 have worked on this case together which is very rare 16 that you see them all indict in the same case, but 17 the FBI, the ATF and the DEA. There were three more 18 arrests which covered eight shootings and another homicide. 19 So this case in general has solved three 20 homicides in this city and solved 15 shootings.

21 We hope this is going to help with our violence 22 in this city. We -- we -- we feel it will. There 23 was even some indictments related to stolen cars. 24 And, therefore, the stolen cars were used in 25 shootings which is a new method that U.S. Attorney's

Office doesn't often use. You don't see them indict
for stolen cars. But, although, it was only three
people like we've always talked about, it's a very
small number of people that commit the violent crime
in the city.

So the first roundup was six. This was three. So we have nine. Actually, they are gang members that were indicted fed -- federally and we'll be moving forward on that. And we thank our partners for that.

And the last thing, if you can put up the flyer, 11 12 Chief Bhagtana. The citizen -- the Resident Civilian 13 Academy. We decided to call it a Resident Civilian 14 Academy because you don't have to be a citizen to 15 live in this city and -- and get the services of the 16 police department. So we took the suggestion of our 17 friends in the community. And it's going to be 18 Resident Civilian Academy. Starting September 6 19 through October 4<sup>th</sup> on Wednesdays from 6:00 to 9:00.

Anyone could sign up. We are going to do a big media blitz of getting people to sign up. And then take through all the topics, you know, structure of the department, ethics, Patrol operations, community policing, Investigative Services, the court system, de-escalation, use of force, pretty much everything Γ

1	we do.
2	It will be at 200 Wintergreen. We encourage
3	anybody to sign up. I'm sure we will have a small
4	segment where any commissioners that want to come in
5	and talk to the group will be able to or any
6	commissioners want to come in and sit in on any of
7	the classes, certainly able to. And this is our
8	opportunity to, again, use our community policing
9	model and keep engaging with citizens and kind of get
10	people to understand why we do things and what we are
11	doing.
