Commission on Disabilities - Meeting Minutes

I. Call to Order – The meeting was called to order at 6:17 PM by Billy Huang, Chair.

- II. Approval of Minutes for September 11, 2023 Billy Huang made a motion to accept the September 11, 20234 minutes. Sally Esposito seconded the motion. During the discussion of the motion, Carmen Correa-Rios indicated that she was not in attendance at the meeting. The minutes were amended to reflect her absence. There were no other comments regarding the minutes. The motion was amended to accept the minutes as edited. The vote on the motion was unanimous approval with Carmen, Sandy, and Griselle abstaining because they were not in attendance at the meeting.
- III. <u>Guest: Sarah Spear and Empowered Together</u> Sarah Spear introduced herself and told the Commissioners a little bit about her history. She then presented her Empowered Together concept to the Commission on Disabilities. The idea is to connect people with accessible businesses. Her PowerPoint presentation and summary sheet are attached to these minutes. Ms. Spear would like to pilot the program in New Haven and have users from the disability community in this area try the app and provide feedback.

Sandra Roberts commented that she liked the idea and thinks it could have potential. Sally Esposito asked how many advisors working on the project have a disability? There are three advisers working on the project, one has a disability and one is a parent.

IV. Old Business

A. <u>Elevator Proposal</u> -The proposed changes to the elevator ordinance were heard by the Alders Legislative Affairs Committee on October 3, 2023. Many of the members of the Commission attended the meeting. Sally Esposito and Billy Huang spoke and provided written testimony. Other members of the Commission were present to provide support. Gretchen Knauff also provided testimony that focused on the changes that the proposal would make to the current ordinance. The Legislative Affairs Committee unanimously approved the proposal and sent to the full Board of Alders.

The Commission members discussed next steps and their concerns about other groups that may oppose the ordinance changes. They decided that it would be beneficial to call

their own Alders to ask them to support the ordinance change and to let them know why the change is needed and why it's important. The Commissioners should also let them know how the ordinance addresses the problem and inform them about the number of city departments that approved the ordinance changes. Gretchen will create a one-page document that can be used by the Commissioners in their discussions with the Alders. It will be sent to the Alders right after Halloween.

Commission members present decided to contact as many Alders as possible to request that the Alders support the legislation. The members present divided up the list of Alders and took responsibility for contacting most of the list. It is hoped that the Commissioners who could not be at the meeting will assist with contacting the remaining Alders. The assignments can be seen in the chart below.
