OPEN SESSION

The Regular Session meeting of the Board of Police Commissioners was called to order at 6:07 p.m., Evelise Ribeiro, Chair, presiding.

- Commissioner Ribeiro indicated that Commissioner Brooks was attending the meeting in person with her at the One Union Avenue.
- Appearing via videoconference were Commissioners Walker and Miranda. She further indicated that Commissioner Meares would not be attending the meeting, and that Commissioner Lawlor would be joining the meeting a little later.

DISCUSSION AND APPROVAL OF MINUTES

Discussion and Approval of the Regular Meeting Minutes of October 10, 2023

- ** Commissioner Brooked motioned to accept the Minutes for October, 2023
- ** Commissioner Walker seconded
- Commissioner Ribeiro indicated there were two scrivener's errors. The minutes should read Regular Session Minutes instead of Special Session indicated at the top of the first page. In addition, Commissioner Ribeiro indicated that there was an indication Commissioner Lawlor joined the meeting but he actually joined in person. The minutes should so reflect that Commissioner Lawlor joined in person.
- ** Commissioner Brooked amended the motion to accept the minutes with the noted corrections for October 10, 2023
- ** Commissioner Walker seconded
- ** Motion passed unanimously

CHIEF'S REPORT

Chief Karl Jacobson

- Chief Jacobson apologized and indicated that there were technical issues that evening.
- There are some personnel matters from Chief Campbel that they want to address. There are detectives that they want to possibly promote. If that happens, there would be a promotional ceremony on November 15, 2023.

- There are people eligible for the next academy class. The hope is to start an academy class on December 1st, 2023. There are 20 to 25 potential candidates who are almost done with every phase of testing.
- On December 6, 2023 from 6:00p.m. to 10:00 p.m. there will be an award ceremony. Invitations were sent out to the commissioners and many people within the public. It will the first award ceremony since 2017. Awards will be given to all officers, detectives, supervisors and some community members.
- Chief Jacobson also reported the change of some district managers. This change was due to some staffing issues.
- Chief Jacobson emphasized that the Department is committed to the Community Policing model. They are going to go from six district managers to four. They are also working on a sergeants' test which they hope to have completed by March of 2024 where the can put some district managers back in some districts.
- In the meantime, Lieutenant Paul Borer was assigned as District Manager for Districts 1, 6 and 7; Lieutenant Fumiatti was assigned as District Manager for District 8 and 9; Sergeant Sanders would remain in Districts 3 and 5; and Lieutenant McDermott was assigned as District Manager for Districts 2, 4 and 10.
- There have been unforeseen retirements. They had to kind of make the changes fast.
- Chief Jacobson publicly thanked the alders and the CMTs for their patience. The Department is moving forward.
- There will be a day when the Department returns to the full Community Polic model.
- The last thing the Chief reported was that Lieutenant Fumiatti would be having Coffee with a Cop on November 15, 2023 from 10:30 a.m. to 11:30 a.m. at Mary Wade, 118 Clinton. He invited all the attend.
- Commissioner Walker asked if CompStat was going to be at Whalley Avenue that week.
- Chief Jacobson reported by saying that week CompStat would be held at Whalley Avenue, District 10, 332 Whalley Avenue at 11:30 a.m. on Thursday, November 16, 2023. They had invited some in the Jewish Community to speak about some of the things the Department have done to make that area safe and secure. It is called Community CompStat. So they are hoping folks from the community would attend.
- Commissioner Ribeiro asked if they had had many people from the community attend CompStat.
- Chief Jacobson indicated that they have about 10 or 15 members of the community attend in person each time. They are working through their IT issues.

INTERNAL AFFAIRS REPORT

Lieutenant Dana Smith

- Lieutenant Smith indicated that the total use of force for this year is 48. At the same time last year, the Department had 653. This a 62 percent decrease as far as the total use of force.
- There were three closed cases for the month. They were all unfounded..
- Commissioner Ribiero indicated that a lot of the numbers are way down in looking at Lieutenant Smith's report. It is worthy of note.
- Chief Jacobson says the use of force is down, however, the officers are doing more work by looking at the Department's data. For example, the Department had made the same amount of gun arrests the previous day as they had made in the whole year. And there is still a month and

half left in the year. Last year, the Department had a record gun arrest year at about 258. Currently, the Department is at about 259 with a month and a half left to go.

- Chief Jacobson indicated that the Department has a total of about 7,000 motor vehicle stops. Whereas, last year at the same time, the Department had 3500 motor vehicle stops. So the officers are actually doing more work and using force less.
- Commissioner Ribeiro said that is awesome. She thanked Chief Jacobson and Lieutenant Smith.

PERSONNEL MATTERS

- Chief Campbell greeted everyone. He thanked the Commission for allowing them to present these candidates. He requested that one of the candidates be tabled, Candidate Rose Dell. He requested that she be presented on November 28, 2023.
- Commissioner Ribiero indicated that the commissioners would have to decide.
- Chief Campbel presented John Healy. He would join their Department as their Captain of Patrol Operations. He retired as a captain from the New Haven Police Department. He is held in high esteem. He had gone through process to vet a police officer. He had passed with flying colors. They were really look forward to him coming to their Department. He personally looked forward to Captain Healy coming on board to help him with operations and moving the Department forward into the future in policing this community at Yale and also the larger community. He has known Captain Healy for well over two decades,. He is a man of integrity and honor. He is a true leader.
- Some members of the Commission had interviewed him. He would be a great candidate for the Yale Police Department.
- Commissioner Ribeiro indicated that they had an opportunity to speak with Captain Healy. The commissioners knew him while he was at the Department. In speaking with him and looking at his resume, they were all very, very impressed with his background.
- Captain Healy thanked Chief Campbell for his kind words. It was great to see his prior Chief, Karl Jacobson, and Assistant Chief Ettienne and obviously some of these officers soon to be detectives but a lot of good people on this list, and obviously the commissioners he knows well. It would be great to continue to work together in the future. This is his next chapter. He looked forward to the opportunity. He was grateful for this opportunity and looked forward to it.
- ** Commissioner Walker motioned to adhere to Chief Campbell's recommendation to hire Captain John Healy to the Yale Police Department
- ** Commissioner Brooks seconded
- ** The motion passed unanimously

- Captain Healy was congratulated and he thanked everyone.
- ** Commissioner Brooks motioned to table the Personnel Matter as it relates to Rose Dell to a later date in time
- ** Commissioner Walker seconded
- ** The motion passed unanimously
 - Commissioner Ribeiro indicated that this matter will be tabled and be brought up at a later date. She thanked Chief Campbel and Captain Healy.
