- Chief Jacobson thanked the commissioners for taking time for this meeting. They would love to start this class on December 1, 2023.
- Chief Jacobson stated that he was presenting a very diverse, very deeply-rooted-in-New-Haven group with six female candidates/cadets. They are very proud of this list.
- Assistant Chief Jacobson further stated that he was very happy that Chief Bhagtana, Sergeant Finch and his crew had put together such a great, diverse group of candidates where many had gone to New Haven public schools and a few still live in New Haven. They are just excited for this group.

- Commissioner Ribeiro indicated that each candidate that was being hired would have to be named for the record.
- Chief Jacobson went on to mention each candidate for the record. He stated that this system was working because they are able merge the lists and get a whole class together.
- Commissioner Ribeiro added by saying that the Department is doing constant recruiting. So they are now able to simultaneously test while there is still a list that is current. As you can see from the dates, that has been happening. Another testing has been scheduled in January. They did make sure the Department was, of course, going through the lists appropriately. We just want to make sure that we are in compliance.
- Sergeant Finch added that the next written examination had been scheduled for January 10, 2024. The oral interview had been scheduled for January 22, 2024. Those conditional offers will go out. But before the conditional offers go out after the candidates pass the test, they always go back to the candidates that may have declined. The candidates do get a choice to decline the first opportunity for a conditional offer. If at any time a candidate declines, then the Department circles back to the candidate, thereby, giving the candidate a second opportunity.
