

- 3. The Tax Collector, acting pursuant to Chapter 205 of the statutes, shall cause to be recorded in the New Haven Land Records a certificate continuing the municipal tax lien, created by Section 12-172 of the statutes, with respect to the tax levied on the Property for the Grand Lists of October 1, 2019, October 1, 2020, October 1, 2021 and October 1, 2022.
- 4. The Taxes shall be due and payable in full upon the earliest of the death of the Taxpayer, or when the Taxpayer no longer resides at the Property, or upon the sale or transfer of title to the Property, whether voluntarily or involuntarily or by operation of law. Interest shall accrue at the rate of six percent per annum (one-half percent per month) on the Tax Principal specified in paragraph 1 from the due date of each installment thereof. Any interest which may have accrued in excess of such rate prior to the execution and recording of the Agreement shall be abated (eliminated). The municipal tax lien and the lien created by the Agreement shall be released by the Tax Collector when the Taxes secured thereby have been paid.

The Department would like to apply for \$200,000.00 for a two-year grant from the Office of Community Oriented Policing Services (COPS) 2024 Law Enforcement Mental Health and Wellness Act (LEMHWA) Implementation Project.

As we all know, good mental health is as essential as good physical health for officers to effectively perform the various and challenging tasks of law enforcement. Dear Honorable President:

New Haven Public Schools provides transportation services to approximately 17,000 students attending 11 high schools, 2 middle schools, 30 elementary and K-8 schools, 9 early childhood program locations, and 19 other education centers. Services are provided on three primary transportation tiers using a total of approximately 315 route vehicles. Additional transportation is provided to support athletic and extracurricular programming. All services are managed and administered by the NHPS transportation staff.

NHPS will be ending its one-year contract extension with First Student on June 30, 2024. A Request for Proposal (RFP) has been drafted and coordinated through NHPS Transportation Department, City of New Haven Purchasing Department, Corporation Council, Mike Gormany, and NHPS Finance department. The RFP was closed on February 6, 2024. A single response to the RFP has been received and was reviewed with City Purchasing and Director of Transportation and district myself to ensure that all areas of the RFP have been met. Further evaluation of the submission was not required or conducted.

Contract costs are based on 180 days of service with pricing provided per vehicle type per day. The total annual cost for each contract is based on the number of routes that are in place at the beginning of each year with enrolment at each school, where students live and what school they will be attending dictating this number. Currently the district has 313 operating routs and busses in service each day across both of the district's existing contracts. This number is only an approximation of routes and changes throughout the year as the operation becomes more efficient, routes are consolidated or split to better serve the needs of the district.

The scope of work and contract for the previous and current RFP were created in large part from the documents created by CESO Group. In October and November of 2023, I conducted a review of concerns raised about the process and comments from the March 6, 2023 RFP process. From these concerns and comments there were several items to be addressed in drafting the new RFP and contract documents. During this time, I also collaborated with the new City Purchasing agent, Corporation Council, and Mike Gormany, Paul Wessel from the Greater New Haven Clean Cities and Steve Winter.

- 1. During review of comments from the previous RFP a clear message was made from staff that splitting the contract into segments presented operational challenges at the school level as well as challenges for parents of children who may be placed on different buses. Requires the use of two applications for tracking Bus GPS locations. Added administrative difficulties for the Finance team in tracking invoicing and payments to two or more contractors providing service.
- 2. In an effort to more effectively score and evaluate submissions a matrix document for respondents to provide answers to documents.



- 3. In order to expand on the bus electrification aspects of the RFP a requirement was added for the contractor to provide a plan for electrification of the fleet by 2030 within six months of the execution of the contract. The intent of the plan is to identify a pathway for the district to have a fully electrified fleet of more than 340 buses by 2030 to be in compliance with State and Federal mandates as well as the NHPS Climate Resolutions approved by the Board of Education. Savings or costs that are associated with electrification would be negotiated and shared with First Student and NHPS. First Student has applied for 25 electric buses through the EPA Clean Air Act Funding. Award of this grant has not yet been announced. Plan development with district staff will begin as soon as contract is in place.
- 4. The purchase of fuel for transportation services under the new contract will be 100% provided by the City of New Haven. In previous contract years there was an allowance provided in the contract and any additional costs were covered by the City of New Haven. With fuel costs taken on by the City of New Haven we have more control over overall costs for fuel for the district. In past contract First Student was responsible for purchasing of fuel in excess of \$500,000.00. This cost would be passed back to the district.
- 5. The Contract term also needs to be more aligned with the mandate for bus electrification allowing for greater continuity. The district must be able to effectively collaborate with a transportation partner who is vested in our success in achieving this goal by 2030.
- 6. The term length was changed to a 4-year contract with 2 options for renewal. Each of these options has fixed pricing. This term will take the district to the 2030 deadline for bus electrification. The two options allow the district an option to put back out to bid should the contractor's plan for electrification prove not to be proceeding appropriately.
- 7. In collaboration with Mike Gormany and City of New Haven Purchasing language was added to allow for the City of New Haven to take advantage of contract pricing for City of New Haven needs related to use of Transportation services.
- 8. The new contract for services requires First Student to replacement of approximately 120 of our existing fleet to new busses to meet bus age requirements set by the City of New Haven Charter for district buses not to be older than 7 years. At approximately \$95,000 each this represents an estimated \$11,400,000.00 First Student must provide as part of their contract costs.
- 9. Evaluation of services to meet contract deliverables is an ongoing process for all vendors. Vendors that are not meeting their contractual obligations are brought to corporation counsel and to City of New Haven purchasing department to determine how to work with the vendor to resolve the issue or in the most extreme of circumstances terminate the contract. The Director of Transportation and the COO are directly involved in resolving issues related to service for transportation. In past contract liquidated damages language was not strong enough to peruse. This language has been strengthened to allow the district to apply liquidated damaged where it applies. First Student has been extremely responsive to service related issues and delivering on the needs of the contracts as these issues arise. First Student has been willing to work collaboratively with the district to improve services when issues arise. Service will never be perfect but we will always be striving for improvement and working together toward that goal. Dear Honorable Tyisha Walker-Myers,

The City of New Haven (the "City") is requesting authorization to apply for and accept funding from the Environmental Protection Agency's (EPA) Climate Pollution Reduction Grant program.

The grant would fund a generational investment by the City of New Haven in the design and construction of the Union Station Area Thermal Energy Network (USATEN) a networked geothermal system to provide the lowest-cost, carbon free heating and cooling to Union Station and the Union Square development across Union Avenue. Networked geothermal systems are unique in their ability to equitably bring affordable clean energy to residents and businesses at the neighborhood scale. USATEN would be designed to support the future addition of adjacent municipal buildings, such as the New Haven Police Department headquarters, and to expand to the nearby Hill South neighborhood.

The City of New Haven would be responsible for managing the design, procurement, and construction of USATEN, and would work closely with the New Haven Parking Authority (NHPA) and the New Haven Housing Authority (NHHA) to complete the grant activities. The City would

work together with the NHPA in order to design, procure, and install a geothermal heat pump to heat and cool the building while eliminating on-site fossil fuel use at Union Station. The City would coordinate the construction of USATEN with the NHHA in order to ensure that the networked geothermal system is sized and configured to allow the new buildings constructed at Union Square to tap into the system using geothermal heat pumps for their heating, cooling, and hot water needs. This will result in utility bills for residents and ongoing operating costs for NHHA that are lower than any other form of energy.

The grant request from the EPA is designed to cover all of the costs that the City cannot recoup through Energize CT geothermal heat pump reimbursement rebates and the federal government's geothermal 40% geothermal direct pay reimbursement incentive. In order to take advantage of these reimbursements, the City would need to provide 40% of the project costs, which the federal government would reimburse after the project is placed in service and Energize CT rebates are claimed.

We respectfully request your honorable Board's favorable action on the attached Order authorizing the Mayor to apply for and accept funding through the Climate Pollution Reduction Grant program.

EXECUTIVE SUMMARY

Environmental Protection Agency Climate Pollution Reduction Grant

New Haven Office of Climate and Sustainability March 27, 2024

Funding request: \$9,420,000.00 over five years

The City of New Haven will design and construct the Union Station Area Thermal Energy Network (USATEN), a networked geothermal system to provide the lowest-cost, carbon free heating and cooling to Union Station and the Union Square development across Union Avenue. Networked geothermal systems are unique in their ability to equitably bring affordable clean energy to residents and businesses at the neighborhood scale. USATEN would be designed to support the future addition of adjacent municipal buildings, such as the New Haven Police Department headquarters, and to expand to the nearby Hill South neighborhood.

The City of New Haven would be responsible for managing the design, procurement, and construction of USATEN, and would work closely with the New Haven Parking Authority (NHPA) and the New Haven Housing Authority (NHHA) to complete the grant activities. The City would work together with the NHPA in order to design, procure, and install a geothermal heat pump to heat and cool the building while eliminating on-site fossil fuel use at Union Station. The City would coordinate the construction of USATEN with the NHHA in order to ensure that the networked geothermal system is sized and configured to allow the new buildings constructed at Union Square to tap into the system using geothermal heat pumps for their heating, cooling, and hot water needs. This will result in utility bills for residents and ongoing operating costs for NHHA that are lower than any other form of energy.

The grant request from the EPA is designed to cover all of the costs that the City cannot recoup through Energize CT geothermal heat pump reimbursement rebates and the federal government's geothermal 40% geothermal direct pay reimbursement incentive. In order to take advantage of these reimbursements, the City would need to provide 40% of the project costs, which the federal government would reimburse after the project is placed in service and Energize CT rebates are claimed.

Mr. Ricardo Torres Jr was born in New Haven on November 11, 1990. Mr. Torres, also known as "Ricky", is an inspiration to residents in the community, where he dedicated himself by pursing his lifelong dream of becoming a firefighter since he was two years old. He was a loving husband to Mrs. Erica Martinez, and is the proud father of Oliver Torres and Crew Torres. He joined the New Haven Fire Department in July 2019 as a proud member of Recruit Class 62 and was assigned to Engine 6, Fourth Division, where he was revered for his camaraderie and dedication. On May 12, 2021, Firefighter Torres made the ultimate sacrifice while responding to a fire on Valley Street in New Haven, demonstrating exceptional courage and heroism in the line of duty. Firefighter Ricardo Torres, Jr. dedicated his life to the service of the New Haven community, exemplifying the highest ideals of bravery and sacrifice. BACKGROUND

This request comes from the Board of Alders regarding the extension of a residential parking zone along Whalley Avenue between Sperry Street and Dwight Street. In accordance with Section 29-55(a) of Title III, Chapter 29, Article III, Division 1 of the City's Code requires that, "Upon petition thereto of the residents of a majority of the residences on a block, the board or aldermen [alders] may create a residential parking zone, which shall include, but not be limited to, that block from which said petition originated."

In this instance, a petition has been signed and submitted because, according to Alder Frank E. Douglas Jr. which states "The residents in the vicinity of 61 Whalley Avenue, where the Sample Shop and Wendy's restaurants are located, were made aware of concerns regarding parking violations and related issues. We have attempted to address these concerns by engaging with the businesses, but regrettably, they have declined to cooperate. The residents in the area have signed the enclosed petition with the abovementioned request. Residents believe that extending Residential Parking Zone 6 (the closest area in RPZ 6 is on Dwight Street) and implementing the 2-hour parking limit will significantly help ease parking issues for area residents who are presently struggling with a severe shortage of on-street parking. However, they are aware that they will need to apply for a Residential Parking Permit, and cars without permits posted will be subject to ticketing by the city."



City Plan staff visited the location of the proposed RPZ on March 15, 2024. It appears that the area of interest is the north side of Whalley Avenue between Howe Street and 61 Whalley Avenue, as shown in the graphic below. This area currently has one-hour parking, not metered.

The proposed two-hour parking would extend the amount of time short-term parkers could park. However, making this area a residential parking zone would allow residents with passes to park as long as they want. This could lead to reduced parking for customers parking short-term to visit the businesses in the area. Many of the businesses along this section of Whalley Avenue, with residential use above, do not have onsite parking and are small businesses. If residents using street parking remove their vehicles during the day, this could be compatible with the businesses' parking needs. However, if residents intend to leave their vehicles parked on the street during the day, the RPZ could have a negative impact on the businesses.



The location of the proposed Residential Parking Zone extension is in the City's Commercial Gateway District, a newer zone district created with very specific goals in mind for the Whalley Avenue Commercial Corridor:

"It is the intent and vision of this sub-district to create a continuous building wall with diverse uses, and to improve the public realm for pedestrians, bike and transit users through redevelopment and infill."

NHZO Section 41

The proposal for a residential parking zone does not appear to conflict with the goals of the Commercial Gateway District. Vision 2025, the city's comprehensive plan, emphasizes the need for bicycle infrastructure on Whalley Avenue. The proposal to add a residential zone to existing parking spaces will not impact the city's ability to make improvements to bike/ped infrastructure in the future.

City Plan consulted with the Transportation, Traffic, and Parking Department (TTP), Engineering Department, and the Economic Development Administration. The proposal will not conflict with the Bus Rapid Transit lane planned for Whalley Avenue. TTP emphasized the need to reword the petition to accurately capture the correct section of Whalley Avenue, as described below, but had no technical concerns. The Economic Development Administration had no concerns with the proposal, taking into consideration future developments and streetscape improvements planned for the area.

RECOMMENDATIONS

• The Board of Alders should consider input from local business owners along this section of Whalley Avenue.

ADVICE

Approval with the following recommendations:

- Revise the petition to clarify the area proposed for the Residential Parking zone as "the north side of Whalley Avenue between Howe Street and 61 Whalley Avenue."
- Remove the two-hour parking proposal from the petition and leave the area with one-hour parking for non-residents.

BACKGROUND

The City of New Haven has been offered two grants totaling \$9,300,000 for the New Haven Shoreline Greenway from the United States Congress Congressionally Directed Spending Program (\$7,000,000) and the Connecticut State Bond Commission (\$2,300,000). The New Haven Shoreline Greenway is a separated mixed-use path stretching from the intersection of East Street and Water Street to the East Haven Town Line (see attached proposed route map).

This 4+ mile path will unite the Farmington Canal Greenway (New Haven to Southhampton MA) with the Shoreline Greenway Trail (New Haven to Madison, CT) to create a system of regional importance. More specifically to New Haven, the path will link the parks and neighborhoods of the East Shore to each other and to the larger New Haven active transportation network.


Many residents have advocated for a greenway in the East Shore for at least two decades, at least as far back as the 2004 Plan for Greenways and Cycling Systems. This path was a significant point of resident engagement in the formation of the New Haven Port Authority a few years later and has been a mainstay of the City's active transportation network planning ever since. As the City is wrapping up the construction of the Farmington Canal Greenway, the New Haven Shoreline Greenway is a unique opportunity to continue our legacy of first-class active transportation corridor that serve a wide variety of transportation needs.

The Congressionally Directed Spending (CDS) funding will be administered by the Federal Highway Administration (FHWA) through the Connecticut Department of Transportation (CT DOT). The CDS funding requires a match of 20% (\$1,750,000) which is covered by the \$2,300,000 grant from the Connecticut State Bond Commission administered through the Connecticut Department of Energy and Environmental Protection (CT DEEP). Together, these funds will provide funding for both design and construction of the New Haven Shoreline Greenway.

While most of the proposed route is on City of New Haven right-of-way or on City of New Haven owned land, there will be some real estate impacts from the project. Specifically, the route crosses the Tomlinson Bridge along Route 1, which will require a maintenance agreement with the CT DOT. This is highly typical, and not dissimilar to the responsibilities for sidewalk in the state right-of-way. Second, the route crosses through a pump station property of the Greater New Haven Water Pollution Control Authority on Morris Causeway. We have had preliminary discussions with the GNHWPCA and look forward to an agreement allowing the path to cross over their property. Third, the path traverses land that is part of the Tweed New Haven airport. While the City ultimately owns the underlying land, the impact of the path will need to be memorialized with the Tweed Airport Authority.

Finally, in an effort to avoid highly regulated areas in the airport, the City will need to acquire a small portion of the parcel known as 181 South End Road, which is a private residence. The portion in question is approximately 1,570 square feet of the 15,681 square foot parcel. This represents approximately 10% of the parcel, but the long, narrow nature of the parcel puts the acquisition line approximately 240' from the back of the residence. Please see attached property map for more detail. The City has approached the property owner who has been amenable to the sale. We will provide more granular detail at the committee hearing.

The New Haven Shoreline Greenway is a particularly special and transformational project, and the culmination of decades of effort by residents and enthusiasts to create a more connected, people-scale New Haven. A particular thanks goes to our federal delegation, the Governor, the state delegation, Board of Alders, and all other elected officials who have worked alongside our administration to secure the very significant amount of funding to carry out this project.

BACKGROUND

The State of Connecticut Department of Transportation has offered a \$669,600 grant to the City of New Haven for the Wintergreen Area Pedestrian Improvements Project as part of the Connecticut Community Connectivity Grant Program. The aim of the project is to improve pedestrian connectivity in the Wintergreen area by installing sidewalk along Wintergreen Avenue, Springside Dr, and Wilmot Rd. These sidewalks will connect Common Ground High School, Brennan-Rodgers School, Brookside, Rockview, and Westville Manor to the City's sidewalk network (see attached plans). These improvements have been advocated for by students and residents for years, and are eagerly awaited.

Due to the narrow width of the Wintergreen Avenue bridge over Wintergreen Brook, a separate pedestrian bridge is needed to provide safe passage for pedestrians. This requires acquisition of property from the Congregation B'nai Jacob cemetery on Wintergreen Avenue. The land in question is at the extreme corner of the property (see attached map) and is currently wooded. Work on the acquisition has already started and details will be provided at the committee hearing.

The grant covers the entire eligible construction cost of the project. The City is undertaking the design of the project, and also the property acquisition. Design is anticipated to be complete later in 2024.
