The following items were presented:

Item 1. Request of Paola Acosta, Alder, Ward 14, for establishing TWO HOUR PARKING 8AM-7PM, MONDAY-SATURDAY regulation on both sides of Pine Street from Atwater Street to Clinton Avenue. Approval recommended.

 - A. Establish RESERVED FOR HANDICAPPED parking spaces.

3. In front of	79 Main Street1 space
4. In front of	52 Elizabeth Ann Drive1 space
5. In front of	79 Pine Street 3 spaces
6. In front of	2 Strong Street1 space
7. In front of	29 Wellington Rd 1 space
8. In front of	504 Woodward Avenue

- B. Rescind RESERVED FOR HANDICAPPED parking spaces.

Approval of A. and B. is recommended.

Douglas Hausladen presented the technical report. Commissioner Ribeiro moved to approve the amended item. Commissioner Miranda seconded the motion. The motion was voted on and approved by a unanimous vote.

- C. Establish LOADING ZONE Regulation.
 - 1. On the east side of York Street at the first two meter spaces north of the Wall Street walkway. (40 feet.) Request of Yale University.

Approval of C. is recommended.

Douglas Hausladen presented the technical report. Commissioner Ribeiro moved to approve the amended item. Commissioner Miranda seconded the motion. The motion was voted on and approved by a unanimous vote.
