## TRAFFIC AUTHORITY MINUTES FEBRUARY, 2019

The meeting was called to order at 6:03 PM, Commissioner Dawson presiding.

The minutes of the September 12th, 2018 meeting were approved.

The following items were presented:

Item 1. Request of Evelyn Rodriguez, Alder, Ward 4, for establishing RESIDENTIAL PARKING regulation on both sides of Portsea Street from Howard Avenue to DeWitt Street. Approval recommended.

Bruce Fischer presented the technical report. Commissioner Diaz moved to approve the item. Commissioner Garcia seconded the motion. The motion was voted on and approved by a unanimous vote.

Item 2. Request of Dolores Colon, Alder, Ward 6, for establishing RESIDENTIAL PARKING regulation on both sides of Howard Avenue from South Water Street to Sea Street. Approval recommended.
