

TRAFFIC AUTHORITY MINUTES
APRIL, 2019

The Traffic Authority of the City of New Haven, duly warned, met in Chambers, One Union Avenue, New Haven, Connecticut on April 9th, 2019.

The meeting was called to order at 6:06 PM, Commissioner Dawson presiding.

The minutes of the February 12th, 2018 meeting were discussed, amended and approved.

The following items were presented:

Item 1. Request of Abigail Roth, Alder, Ward 7 for establishing ALL WAY STOP control of the intersection of Lincoln Street and Bradley Street. Approval not recommended.

Doug Hausladen presented the technical report. Commissioner Ribeiro moved to table the item. Commissioner Diaz seconded the motion. The motion was voted on and tabled by a unanimous vote.

Item 2. Request of Abigail Roth, Alder, Ward 7 for establishing ALL WAY STOP control of the intersection of Lincoln Street and Pearl Street. Approval not recommended.

Doug Hausladen presented the technical report. Commissioner Ribeiro moved to approve the item. Commissioner Diaz seconded the motion. The motion was voted on and approved by a unanimous vote.

Item 3. Request of Ron Hurt, Alder, Ward 3 for establishing TWO HOUR PARKING 8AM-7PM, MONDAY-SATURDAY regulation both sides of Davenport Avenue from Kossuth Street to Elliot Street. Approval recommended.

Doug Hausladen presented the technical report. Commissioner Ribeiro moved to approve the item. Commissioner Diaz seconded the motion. The motion was voted on and approved by a unanimous vote.

Item 4. Request of the Department of Transportation, Traffic and Parking for parking controls less than one block in length as indicated.

A. Establish RESERVED FOR HANDICAPPED parking spaces.

- 1. In front of 136 Blake Street..... 1 space
- 2. In front of 282 Davenport Avenue..... 1 space
- 3. In front of 324 Goffe Street..... 1 space
- 4. In front of 625 Howard Avenue..... 1 space
- 5. In front of 249 Newhall Street..... 1 space
- 6. In front of 415 Shelton Avenue..... 1 space
- 7. In front of 91 Sherland Avenue..... 1 space

Approval of A. is recommended.

Doug Hausladen presented the technical report. Commissioner Diaz moved to approve the item. Commissioner Ribeiro seconded the motion. The motion was voted on and approved by a unanimous vote.

Item 5. Presentation to the Traffic Commission on the use of autonomous vehicles on New Haven streets.

Presentation by a representative of Stantec regarding a proposed collaborative application by the New Haven Parking Authority and Yale New Haven Hospital to deploy autonomous shuttle vehicles on downtown streets with a question and answer session.

Item 6. Presentation to the Traffic Commission on Downtown Crossing Phases 2 and 3.

Presentation by Doug Hausladen on Phases II and III of the Downtown Crossing Project.
