- Item 2. Request of the Department of Transportation, Traffic and Parking, for establishing BIKE LANES in both directions on Norton Street from Derby Avenue to Whalley Avenue. Approval recommended.
- Item 3. Request of Alder Jill Marks, Ward 28 and Alder Brian Wingate, Ward 29 for rescinding STOP CONTROL of Munson Street at Crescent Street and Winthrop Avenue at Crescent Street and for establishing YIELD CONTROL of Munson Street at Crescent Street, Crescent Street at Winthrop Avenue, Winthrop Avenue at Crescent Street and Crescent Street at Munson Street.
