INTRODUCTION

The City Plan Department is updating the 1983 coastal policies plan known as the "Coastal Program."

This plan forms the basis of the City Plan Commission's coastal site plan review findings and is an essential part of the review of zoning applications, coastal land use decisions and public investment priorities.


BENEFITS OF COASTAL MANAGEMENT

- Protect coastal resources
- Provide public access
- Protect and provide water-dependent uses
- Natural hazard mitigation
- Maintain or improve water quality

SOME DEFINITIONS FOR THIS DISCUSSION...

- Connecticut Coastal Management Act (CCMA) Requires
 municipalities to review certain activities within the Coastal Boundary
 for consistency with goals and policies established by the Act.
- Provides for development of local plans and regulations known as Municipal Coastal Programs.
- <u>Coastal Boundary</u> Boundary representing the limit of the 100-year coastal flood, or located 1,000 feet from a tidal wetlands boundary, or located 1,000 feet from the mean high water line, whichever is farthest inland.
- Coastal Management District Zoning district that includes all parcels within or partly within the Coastal Boundary.

COASTAL MANAGEMENT AREA



COASTAL MANAGEMENT ACT

Protect and restore coastal resources

 Promote <u>water-dependent uses</u> (facilities that require direct access to, or location in, marine or tidal waters) and <u>public access</u> on waterfront sites

Balance economic growth and resource protection

WATER-DEPENDENT USES

- Marinas
- Ferry terminals
- Public access (trails, parks)
- Public moorings
- Commercial fishing facilities
- Shipyards

NON-WATER-DEPENDENT USES

- Condominiums
- Residential subdivisions
- Retail stores
- Places of Worship

STATUTES FOR MUNICIPAL COASTAL PROGRAMS

 Coastal municipalities may adopt a municipal coastal program for the area within the coastal boundary and landward of the mean high water mark.

STATUTES FOR MUNICIPAL COASTAL PROGRAMS

A municipal coastal program shall include, but is not limited to:

(1) Revisions to the municipal plan of conservation and development... to include an identification and written description of the municipality's major coastal-related issues and problems such as erosion, flooding, recreational facilities, and utilization of port facilities and to include a description of the municipal boards, commissions and officials responsible for implementing and enforcing the coastal program....

STATUTES FOR MUNICIPAL COASTAL PROGRAMS

- (2) Revisions to the municipal zoning regulations and revisions to the following regulations and ordinances insofar as such regulations or ordinances affect the area within the coastal boundary:
 - (A) Historic district ordinances;
 - (B) Waterway encroachment line ordinances;
 - (C) Subdivision ordinances;
 - (D) Inland wetland regulations;
 - (E) Sewerage ordinances;
 - (F) Regulations governing filling and removal of soil;
 - (G) Ordinances concerning protection of the environment; and
 - (H) Regulations for the operations of a sewerage system.

NEW HAVEN ORDINANCE FOR COASTAL MANAGEMENT DISTRICT

- Administered through Section 55 of the New Haven Zoning Ordinance, the Coastal Management District.
- Ensures that development, preservation or use of the land and water resources of the coastal area proceeds in a manner consistent with the capability of the land and water resources to support development, preservation or use without disrupting the natural environment or economic growth, and to ensure public access along the waterfront and the preservation of a natural vistas.

NEW HAVEN ORDINANCE FOR COASTAL MANAGEMENT DISTRICT

- A coastal site plan review shall be conducted for all buildings or activities located in the coastal management district.
- Review determines whether impacts of the proposed activity on coastal resources and water-dependent development activities are acceptable under the Connecticut Coastal Management Act.
- City Plan Commission administers Coastal Site Plan Reviews.
- City Plan Commission is responsible for Coastal Planning and administration of the Municipal Coastal Program.
- Municipal Coastal Program must be consistent with the CCMA, the City Charter, ordinances, and regulations.

EXAMPLES FROM OTHER MUNICIPALITIES

- Contacted Bridgeport, Groton, Milford, New London, Norwalk, Stamford, West Haven, Clinton, Westbrook, and Old Saybrook
- All but Bridgeport and Stamford have written Coastal Programs
- All rely on sections of their zoning regulations to regulate activities in the Coastal Management District
- Programs for Bridgeport, Groton, Milford, New London, Norwalk, Stamford, West Haven, and Old Saybrook are outdated
- Some municipal officials indicated the need to update their Coastal Programs to address increasing development pressure in the districts


EXAMPLES FROM OTHER MUNICIPALITIES

- Important topics in the towns with older Programs include preserving views and regulating construction practices
- Coastal Programs for Clinton and Westbrook were written in 2005
- Clinton intends to use the Program as a guidance document and planning tool
- In all cases, jurisdiction of the coastal management district falls within Planning & Zoning
- Project review and site inspection conducted by the same municipal officials that review P&Z-regulated projects outside the coastal district



OBJECTIVES FOR THE UPDATED COASTAL PROGRAM


- Balance economic development, environmental concerns, and public access and enjoyment.








OBJECTIVES FOR THE UPDATED COASTAL PROGRAM




OBJECTIVES FOR THE UPDATED COASTAL PROGRAM




OBJECTIVES FOR THE UPDATED COASTAL PROGRAM


OBJECTIVES FOR THE UPDATED COASTAL PROGRAM

 Specific objectives may include some or all of the following:


 Conservation of land in the Quinnipiac River estuary to allow for marsh protection and;

PRELIMINARY QUESTIONS AND CHALLENGES

- How will the City implement the components of the Program in the Site Plan review process?
- How will conflicts be resolved between coastal access and security?
- The coastal area is so large Is there a way to streamline the review process?
- The City must be able to defend approvals and denials.
- The City needs a process for making amendments to Zoning Section 55.
- Graphics of the Program need to be improved.

PRELIMINARY QUESTIONS AND CHALLENGES

- Is there a particular staff person or position that should be dedicated to inspections during and after coastal site plan reviews?
- How do other municipalities administer their coastal programs?
- How do other municipalities conduct inspections?
- Needs to be a way to provide public access at residential, non-water dependent projects.
- Program needs a "Progress" section that describes benefits of the Program and examples of successes.
- Should a new type of zoning, "Open Space," be proposed?

Goals and Objectives for the Coastal Program

- Improve/strengthen public access
- Recommend public access design standards
- Record public access on land records
- Purchase easements and development rights
- Improve water quality and stormwater runoff from sites
- Recommend buffers between water and developments
- Protect and improve view sheds
- Strengthen ties to historic districts
- Assist property owners with erosion control guidelines
- Complete greenway and waterfront park linkages
- Implement open space designation

Goals and Objectives for the Coastal Program

- Protect Quinnipiac Meadows from development
- Implement monitoring of wetland/water encroachment
- Implement habitat trading/mitigation
- East Shore and Morris Cove flood mitigation
- Steer proper economic development into coastal zone
- Monitor Port Authority development
- Monitor and encourage Mill River redevelopment
- Monitor and encourage River Street redevelopment
- Acknowledge existing "nonconforming" land uses
- Balance existing uses/new owners/proposed uses

Recommendations for Site Plan Review

- Improve application materials and forms
- Expand public participation in plan review
- Conduct 5-year reviews of permits and projects
- Implement a streamlined review for "no impact" (distant) projects

Recommendations for City Property


- East Shore and Morris Cove flood mitigation




Canal / Belle Dock -- Land Use




City Point -- Land Use




East Shore -- Land Use




Fair Haven and Mill River -- Land Use




Long Wharf -- Land Use
