# PUBLIC COMMENT

■ Ms. Monica Bell, a resident of 360 State Street, commented that there was an emergency lockdown at the said address in response to a mental health call. She thought it was a call regarding someone threatening suicide. She had a lot of question regarding what happened and concerns. She was concerned as a member of the public that a large shutdown was called for due to mental health call. The SWAT team and hostage negotiators were called as well. It seemed like it would have been more fitting to have something like co-responder model or something like that given that allegedly there was a gun involved.

■ Ms. Bell further stated that she had a broader concern given that she resides in one of the apartment buildings. And it was time that wellness checks were going to done. Either it didn't occur or it was understood that this person was not real. So, there's a lack of clarity regarding what happened there. So, she was in attendance more for some clarification. She wanted proposals about better ways of handling calls of that nature going forward. She was curious about any potential policy changes that the police department was thinking about in that vein.

■ Commissioner Ribeiro asked if Ms. Bell was seeking clarification for that particular incident or the overall policy when a call like that comes to the Department.

■ Ms. Bell indicated she was asking about both.

■ Commissioner Meares asked if there were over 500 units at 360 State Street. Ms. Bell replied that she was correct.

■ Commissioner Meares said when Ms. Bell said lockdown, she meant everybody in the building was told that they couldn't leave their apartments.

■ Ms. Bell said there was an e-mail sent in all caps to all 500-plus units that they needed to stay in their apartments. And it was explained kind of in several e-mails over time that the police department was on site. She thought it was possibly an active shooter or something like that given the nature of the communications. Then they were told that the police department was doing wellness checks and this was around 11:17 p.m. or thereabouts. And then at 1.21 a.m., the community got an all-clear e-mail from the office managing the building. At about 8:00 a.m. the office explained that the police department was doing its work. They thought there was a mental health concern but they needed to exercise due diligence and to explain the lockdown. But it was in fact the case that all of us were required to stay in our apartment from about 9:19 p.m. to 1:21 a.m. with no explanation of what was going on. Further details were not shared with the residents in the apartment building.

■ Commissioner Ribeiro indicated that in the interest of time she would ask the Chief or her designee to briefly respond to her questions. If Ms. Bell gives the Board her name and contact information, they would get back to her with the particulars and advise the residents in the building accordingly.

■ Chief Dominguez suggested that Ms. Bell type her contact information in the chat. They can connect offline and she could go into more details. The Department received a call for an emotionally distressed individual. The information was received from a third party. So, the

Department was having issues as to whether the individual was in fact located at 360 State Street or not. It was a very long process. The Department did not have a resolution that evening as to where the person was. However, they were finally able to determine that the person was not in the building. The following day they had a call from this individual. They believe more is going on. The hostage negotiator was there because he/she is part of their crises team who would have been able to negotiate mental health issues. They stayed on the phone for probably eight hours with this individual trying to determine where he in fact was located. They are unsure why the 360 State Street address came up. The Department exhausted all means and used all its federal partners to pinpoint where this individual in fact was located.

■ Chief Dominguez went on to say that the only reason for the lockdown was because initially the only information they had was a mental distressed individual in the building and it was for the safety of the others while they were trying to locate this individual. She indicated she would be glad to speak with Ms. Bell the following day. The Department released a statement that night. The management company was trying to communicate with the residents. She indicated that they would like to hear Ms. Bell's thoughts on ways they could have done better keeping in mind that the safety of residents is always the Departments first priority.

■ Commissioner Meares indication that in addition to this specific incident, the Efficiency Committee is undertaking a policy review. She would like the particular policies that the officers were following in order to respond to this incident. It should be identified as a general matter. She understood what Chief Dominguez said. It might be that there are better ways to keep people safe. This was 500 units locked with no information in the context from which we live. Some policy review is in order.

■ Commissioner Ribeiro asked that Chief Dominguez send the policy to the Efficiency Committee and cc her in terms of the particular policy or policies for this incident just the Board's review.

■ Commissioner Lawlor asked if there was ever a sense that this individual might have been armed with a firearm. He thought somebody said that.

■ Chief Dominguez said, yes, there was a sense that this individual was armed with a firearm.

■ Commissioner Lawlor indicated this was a very important factor to be aware of in determining the appropriateness of the response.

■ Chief Dominguez indicated she would be happy to discuss with the Board offline. She would give more information to Ms. Bell as well.

Commissioner Ribeiro indicated that if this information was pertinent for the public to hear now, she would allow further explanation. However, if it was something that the Chief had to look into further, that is fine.

■ Chief Dominquez indicated that what was released to the public was pretty much what she had said earlier without getting too much into the details of the case for obvious reasons.

#### **CHIEF'S REPORT**

Chief Renee Dominguez

■ Chief Dominguez indicated she would highlight some good things that have happened over the week. The New Haven Police Department and the training academy had a bicycle crash investigation training. They had 35 officers from all over the tri-state. Individuals from New Jersey, Maine, Massachusetts were in attendance. It was an SRR Training also run by NESPIN (New England State Police Information Network). There have been lots of bicycle fatalities to be able to do accident reconstruction in order to give officers a little bit more investigatory skills and to come up with ways to prevent future crashes. It was a five-day training course heavy on reconstruction, how to look at them, mathematical models and formulas and also human factors that can contribute to some collisions and how to better prevent theses in the future. So, it was a great class by three of the Department's officers from the accident reconstruction team. It was great to bring the training to Connecticut. It is good to see officers come from other agencies to New Haven to see what the Department is doing and to network with the officers who are doing the work in the field.

■ Chief Dominguez added that the motor unit has been expanded to the evening shift. During the pandemic the Department was unable to get these officers certified regard the motorcycle operators' course. There were three officers from the Department along with 12 other officers around the state. They graduated successfully from the program. It was an intense three-week program. There were a lot of bumps and bruises. And Officer Ramirez of the Department was the top rider. And he was recognized as the top performer in the three-way course which is something very, very difficult to come out on top because the course is very difficult. They had been practicing for months and months especially during the pandemic. So, there are three more official motorcycle operators who are in the city.

■ Chief Dominguez indicated that there were 60 non-fatal shootings to date and 17 homicides. This time last year, there were 56 non-fatal shootings and 12 homicides. The Department is well aware of the work that needs to be done. The Department is continuing to exert efforts to combat violence with a complete department-wide strategy. Since January 1, 2021 the Department has seized 96 guns and made 94 arrests and six more arrests are pending. That is more than they did at the same time last year. Even with the number of seizures and arrests, the violence persists. The Department is working with its partners, such the court, Probation, Parole to continue to think outside the box and use strategies that are known to have worked in the past. The Department is finally beginning to see a decrease. The numbers compared to previous years are still high. However, the Department is seeing results because the numbers are beginning to level off. At the beginning of February, March and April the numbers in the past.
■ The Department is going to have a Project Safe Neighborhoods call-in on July 26, 2021 whereby about 35 individuals would be called. calls. They are doing both Project Longevity and Project Safe Neighborhoods (runs every other month). In the off months the Project Longevity call-in are done.

■ This is talked about much too often. However, being able to do notifications and provide resources to individuals is very important. Having information about the people who are going to be victims of violent crimes or perpetrators of violent crimes is what helps the Department. Lack of resources sometimes is the reason the violence continues to persist.
