There was one response to the RFQ, Alyson C. Heimer. Heimer has been selected to continue to serve the Fund for the next year with a one year renewal option.

Administrator has completed the initial training with the Elicker Campaign and approved their online contribution form. They are actively raising money with the intention of applying for the grant later in the Spring.

b. Ordinance language changes

The Administrator prepared a (growing) wishlist of ordinance changes. The ordinance will be made available to be workshopped by William Wynn and Aaron Goode, who will make up the subcommittee for this project.

c. Board Elections

At the March meeting, those interested in running for an Executive Board position should make their intentions clear. The board will vote on a new executive board at the April meeting. Positions are outlined in detail in the NHDF bylaws.
