

Dear President Walker-Myers:

We write to request that the members of the New Haven state delegation support legislation in an upcoming special session to safeguard our right to vote by amending the criteria for applying for an absentee ballot.

The right to vote is fundamental to a democratic society. In the midst of a pandemic in which social distancing and staying at home are widely advised, casting one's ballot should involve risking one's health. The April 7<sup>th</sup> election in Wisconsin clearly demonstrates the risk of in-person voting during this pandemic, as dozens of voters and pollworkers were reportedly infected on Election Day. Without changes to state regulations regarding absentee balloting, Connecticut risks endangering its citizens and harming its most vulnerable communities as they seek to make their voices heard.

While the Secretary of State has announced that she will mail all registered voters absentee ballot applications with return postage paid, currently the law only allows one to apply for an absentee ballot on account of "his or her illness". The Connecticut General Assembly should amend state statute to allow for absentee voting due to fear of contracting or spreading illness.

It is vital to our democracy and our public health that the legislature address this issue when they reconvene in special session to consider revisions to the state budget. We urge all members of the New Haven delegation to the General Assembly to safeguard the right to vote by amending the criteria for applying for an absentee ballot.

WHEREAS: the right to vote is fundamental to a democratic society; and

**WHEREAS:** humanity is in the midst of a pandemic in which social distancing and staying at home are widely advised; and

WHEREAS: casting one's ballot should not involve risking one's health and the health of others;

**WHEREAS:** the April 7<sup>th</sup> election in Wisconsin clearly demonstrates the risk of in-person voting during this pandemic, as dozens of voters and pollworkers were reportedly infected on Election Day; and

**WHEREAS:** currently state statute only allows one to apply for an absentee ballot on account of "his or her illness"; and

**WHEREAS:** the Connecticut General Assembly is expected to meet in special session to consider revisions to the state budget; and

**WHEREAS:** the Connecticut General Assembly has the authority to amend state statute to allow for absentee voting due to fear of contracting or spreading illness.

**NOW, THEREFORE, BE IT RESOLVED** that the New Haven Board of Alder hereby urges New Haven's delegation to the General Assembly to safeguard the right to vote by amending the criteria for applying for an absentee ballot.

**BE IT FURTHER RESOLVED** that a copy of this resolution, duly adopted by the Board of Alders, be forwarded to New Haven's delegation to the Connecticut General Assembly.

I am pleased to submit for your consideration a grant application and resolution for the Robert Wood Johnson Foundation Grant: Global Ideas for U.S. Solutions: Cities Taking Action to Address Health, Equity, and Climate. The City Plan Department and Department of Transportation, Traffic and Parking is submitting this this application to the Robert Wood Johnson Foundation for a Grant of up to \$600,000.00 over a 30 month period. The exact budget is to be determined. This grant does not require a match. The grant is focused on developing policy and practice for cross cutting challenges of Health, Equity and Climate.

The deliverables include comprehensive Green Ordinances to reduce climate impacts on health as well as inclusive engagement through programmed active transportation events. The engagement models include the "Talking Streets" model from Cape Town SA and "Ciclovia" from Bogota, Columbia, also implemented around the US. The geographic focus area proposed is the Whalley/Grand Corridor but this could be scaled and adapted to other areas in New Haven. Such efforts would build on work on prior work by City Plan, Engineering and Food Policy Director to advance Green Ordinances and participatory planning, as well as work by TTP on health equity and community engagement through the REACH grant. Partners in the grant include CT Department of Health, Yale Center for Climate and Health and UCONN Plant Science and Landscape Architecture.

WHEREAS: The Global Ideas for U.S. Solutions: Cities Taking Action to Address Health, Equity, and Climate grant opportunity was announced by the Robert Wood Johnson Foundation and the City of New Haven (the "City") worked to develop applications in a manner consistent with the foundation grant requirements; and

WHEREAS: the City has highlighted the need for sustainability and climate mitigation in its Climate and Sustainability Framework Plan (2018) Comprehensive Plan Update, Vision 2025 (2015), Plan for Greenways and Trails (2004); and

WHEREAS: Environmental Determinants of Health and Health Inequities are disproportionately affecting New Haven's most vulnerable populations are place based and affected by climate change impacts; and

WHEREAS: the Robert Wood Johnson Foundation grant **Global Ideas for U.S. Solutions: Cities Taking Action to Address Health, Equity, and Climate** seeks to implement innovative practices from global cities in a US city context; and

WHEREAS: the RWJF grant may be used to support alternative transportation plans and community events (pedestrian or bicycle); and improve air quality

WHEREAS: the RWJF grant may be used to collect data and participatory input for purpose of developing Green Ordinances to mitigate climate change impacts and improve air quality, storm water management with direct benefits to health and safety

WHEREAS: recognizing the highly competitive nature of the RWJF grant program, the City is making application for up to \$600,000 funding, with

WHEREAS: the grant activities would contribute to the health equity by providing opportunity for informing policy, improved air quality, outdoor exercise, environmental understanding and supports the livability of New Haven; and

WHEREAS: the grant activities would be a joint endeavor with City Plan, Transportation, Traffic and Parking, Engineering Department and Food Policy Departments and builds on existing programs and initiatives within those department; and

WHEREAS: the grant activities would be a joint endeavor with CT Department of Health, Yale Center for Climate and Health, and UCONN School of Plant Science and Landscape Architecture and other local nonprofit partners; and

NOW THEREFORE, BE IT RESOLVED THAT: the Board of Alders authorizes the Mayor, Justin Elicker, to apply for, execute, acknowledge, implement and deliver any and all documents as may be considered necessary or appropriate for the Connecticut Recreational Trails grant; which documents may include indemnifications of the federal or state agencies involved in the funding, to the extent necessary in order to obtain the same; and

BE IT FURTHER RESOLVED THAT: the Mayor may enter into such agreements for RWJF grant funding for lesser amounts, in the event the City is awarded a grant at a lower funding level, and

BE IT FURTHER RESOLVED THAT: the Mayor may enter into subsequent agreements with the partner organizations or other entities in a manner consistent with RWJF program regulations.

## **Robert Wood Johnson Foundation Grant Project Focus, Components, and Activities**

The project applies three interrelated public engagement programs from Cape Town, South Africa: Open Streets, Talking Streets, and StreetLab. Open Streets are events that temporarily open streets to people by closing them to cars. Talking Streets are organized walking meetings amongst residents, activists, built environment professionals, and others to discuss how a community's streets are designed and function, and how they can be improved. StreetLab is a space for experimentation and learning around urban design policy change. These activities have had \_\_XX\_\_\_ impact on climate change, health, and equity. While these concepts previously have been used to inform transportation actions only, we propose to expand them to inform neighborhood design and the built environment more broadly. In doing so, we follow best practice in building community resilience to climate change that calls for "hyper local" and community-driven adaptation action.

We will put these three innovative concepts into action in New Haven, Connecticut, a small, diverse New England city of 130,000 residents. Our community engagement efforts will focus on the Edgewood, Dwight, Hill District, and Fair Haven neighborhoods, which run along the spine of Whalley Avenue to Grand Avenue corridor. These four neighborhoods reflect New Haven's ethnic and racial diversity, as well as its deep economic, social, and health disparities. They are predominantly low-income, with disproportionate incidence of poor health outcomes (including asthma, diabetes, obesity, COVID rates) and high reliance on public transportation.

Utilizing the ground-up approach, the City will revisit and inform existing land use and transportation policies, to maximize their public health, health equity, and climate change mitigation and adaptation benefits. Specifically, the public engagement processes will shape the City's Green Ordinances and the Active Transportation Master Plan, with the possibility for additional policy change through coalition-building during the grant period. The project also will support the City's efforts to develop, experiment, and codify new institutional practices of public engagement into its planning processes.

The project's four primary objectives are:

- 1. Using Talking Streets and Open Streets, facilitate a process to collect and record residents' knowledge about their neighborhood, their perceptions on how the local environment affects their health, and their visions for the future of their neighborhoods
- 2. Combine the collected community knowledge with spatial data on health outcomes, environmental factors, and climate projections to develop an online mapping tool that educates the public and informs City policy
- 3. Using StreetLab, convene community residents, civic leaders, and City staff to iteratively generate ideas on green ordinance principles and active transportation plan elements, informed by the mapping tool and additional community engagement
- 4. Achieve action within the grant period by securing approval by the Board of Aldermen of four new or updated green ordinances, \*\*TRANSPORTATION OUTPUT\*\*, and updates to City Plan's public engagement procedures

The project addresses the following focus areas: buildings; transportation, land use and urban planning; and climate adaptation/resilience. It engages the urban planning and transportation sectors, with additional connections to the engineering and food policy sectors.

We expect that the project will address the intertwined threats of health, equity, and climate change by changing city planning, policies, and programs in three ways:

Institutionalize inclusive community engagement techniques into city government practices to build equitable community resilience to climate change Through ground-up and inclusive community resilience planning, there is an opportunity to ensure that those most affected by an issue are empowered to shape the decisions that will impact their lives. The process itself can build resilience by increasing connections between community members — which builds social cohesion — and cultivating community leadership. Our proposed Walking Streets and StreetLab will equip the walk leaders and participants to combine climate change projections and community knowledge into policy solutions and practices that best serve their community's needs. In year 3, StreetLab's Walk Leader members also will deliver recommendations about community engagement best practices learned through the project to city agencies (City Plan, Transportation, others), to be incorporated into city practices.

# Codify built environment and urban design changes in 4 green ordinances that address climate threats including the urban heat island effect, urban flooding, and local food security

This project builds on ongoing collaboration between the City of New Haven's City Plan, Food System Policy Division, and Engineering departments to systematically and methodically update a set of Green Ordinances. Planned project outcomes include the update to two existing green ordinances, the Stormwater Management Ordinance and the Reflective Heat Impact Ordinance, and the development of two new green ordinances, the Urban Agriculture Ordinance and the Vacant Lot Policy.

Make active transportation safer and easier, thereby reducing transportation related greenhouse gas emissions, particulate matter, and other air pollutants

FURTHER, IT IS HEREBY ORDERED, that the Mayor be and hereby is authorized to execute and deliver on behalf of the City of New Haven such documents as may be considered necessary and appropriate to implement the intent and purposes set forth in this Order.

# Grant Summary for ORDER OF THE BOARD OF ALDERS AUTHORIZING THE MAYOR TO ACCEPT GRANT FUNDS FROM THE AARP COMMUNITY CHALLENGE

"The AARP Community Challenge grant program is part of the nationwide AARP Livable Communities initiative that helps communities become great places to live for residents of all ages. The program is intended to help communities make immediate improvements and jumpstart long-term progress in support of residents of all ages. The AARP Community Challenge grant program is part of the nationwide AARP Livable Communities initiative, which helps communities become great places to live for residents of all ages. As part of this effort, AARP staff and volunteers engage and mobilize residents, delivering technical assistance and expertise to local leaders and organizations, and supporting the work of the communities."<sup>1</sup>

If awarded, this project will allow for right-of-way improvements to calm traffic and improve transportation facilities for those who are walking, biking, rolling, and strolling near one of New Haven's three public senior centers. The Dixwell/Newhallville Senior Center serves seniors in an under-resourced neighborhood in New Haven. Approximately 30% of New Haven households do not own a vehicle, meaning that safe alternative modes of transportation are critical to life in the city.

This project will enhance pedestrian and bicycle facilities along a half-mile area of roadway directly proximate to the Dixwell/Newhallville Senior Center. This area is also very near to a major high school, an elementary school, and many residences, providing a large community benefit for all roadway users.

This project will include installation of curb bump-outs using paint, traffic tape, and delineator tubes, enhanced crosswalk markings, and improved bike facilities (there are currently only marked sharrows on this stretch of roadway). New Haven has deployed similar right-of-way interventions before as part of a broad "Safe Routes for All" master planning process for active transportation infrastructure. These interventions are increasingly necessary as New Haven has tracked with the rest of the country with an increase in pedestrian fatalities. Unfortunately, since January 1, 2020, New Haven has already had four pedestrian fatalities.

Interventions like the one proposed serve an important dual purpose. In addition to temporarily making an area safer, it also introduces drivers (and non-drivers) to the idea that the right-of-way is a shared resource. After so many years of roadways being built almost exclusively for vehicles, it is a cultural and behavioral shift to condition users to expect various modes of transportation.
