

The New Haven Health Department (NHHD) is well-versed in providing public health programs that support individuals with substance use disorder and opioid use disorder. As the first municipality in the State of Connecticut to offer a syringe service program, the City of New Haven has remains committed to offering evidenced-based programs to reduce morbidity and mortality from overdoses. From the late 1980's until 2016, the NHHD operated the City's only syringe access program, which provided syringes/needles and safe injection equipment for individuals who injected drugs, provided the evidence-based program, Safety Counts, which aimed to reduce the risk of HIV among people who inject drugs by helping individuals develop personalized risk reduction plans, and directly linked individuals to substance use treatment programs. From 2017 to present, the NHHD conducted community outreach and education on how to recognize and respond to an overdose, including the administration of naloxone, worked to reduce the stigma related to opioid use disorder, and, in collaboration with Quinnipiak Valley Health District and East Shore District Health Department, conducted annual DATA 2000 trainings for medical providers. During this time, the NHHD was one of the few health departments/districts in Connecticut to pilot-test the Syndromic Surveillance System.

The NHHD, whose mission is to ensure and advocate for the health and well-being of New Haven residents, has had its roots firmly grounded in the community since the 1600s addressing public health challenges, including poor sanitation and large-scale epidemics of communicable disease. With its continued growth, the NHHD expanded the services it offers. These programs and services currently include, but are not limited to, testing, diagnosis, and treatment of sexually transmitted infections, pediatric immunization outreach, health education, public health nursing, the evidenced-based program Family Check-Up[®] / Every Day Parenting[©], communicable disease surveillance, and Ryan White Part A. Through their work throughout the City, staff have developed partnership with local health care providers, including prescribers at the City's federally-qualified health care centers (Fair Haven Community Health Care and Cornell Scott Hill Health Center) and Yale Primary Care Center. These relationships, along with current and previous work related to substance use disorders, make the NHHD is uniquely suited to implement the academic detailing program with local prescribers and pharmacists.

The New Haven Health Department would hire a part-time (19 hours per week) community health worker (CHW) to conduct the academic detailing. The CHW will be responsible for participating in the academic detailing training, engaging providers and pharmacists in academy detailing and for completing the lessons with these individuals. Brooke Logan, Health Programs Director, will oversee the program implementation and supervise the community health worker.





I hereby move to discharge the following legislative item from the Health & Human Services Committee for immediate and favorable action at the March 1 meeting of the Board of Alders:

• From Alders Walker Myers, Morrison, Furlow, DeCola, Rodriguez, Clyburn, Santiago, and Marchand submitting an Order of the New Haven Board of Alders establishing the legislative priorities for the New Haven Board of Alders and calling on city partners to increase their commitment of resources in order to enable the city to provide services and to advance key policy priorities.

This matter was submitted to the Board of Alders on February 16, 2021 and received a public hearing before the Health & Human Services Committee on February 25. It was the board's most well-attended videoconference meeting to date, with more than 100 members of the public and a majority of the Board of Alders engaged in the process. Several dozen people testified, with no opposition to our new legislative priorities.

Committee members and other Alders present agreed to request this Motion to Discharge for immediate and favorable action, so that the Board of Alders can begin implementing these crucial legislative priorities.
