Ms. Marcano informed that Michael Pinto, COO of the Bd of Education as well as Sabina Sitaru from the Bd of Education were present to explaine to the Board the need for a temporary pending test hire for this position. Mr. Pinto informed the Board that given the current COVID-19 situation, this position is mission critical for the Bd of Education in assisting to maintain the much needed technological infrastructure of the district's shift to on-line learning.
