Meeting opened at 12:34 P.M. Ms. Marcano explained that there were several items that did not make it to the agenda and would need to be added by vote. # **#2 Temporary Pending Test Requests**

Ms. Marcano explained that there was nobody from the Department available that day, and went on to explain that the Parks Department had two sets of resignations for Park Rangers, while they also have their summer programming starting. The Board asked several questions, which Ms. Marcano answered to the satisfaction of the Board. Commissioner Rodriguez moved to approve the temporary pending test request for the Park Ranger position in the Parks Department. Seconded by Commissioner Mongillo. Votes taken; all yeas, none opposed, no abstentions. Temporary Pending Test Request approved.

Ms. Marcano presented results and provided testing and pass/fail data for list #21-5 School Security Officer. Commissioner Mongillo moved to approve the eligibility list for an initial period of one year. Seconded by Commissioner Rodriguez. Votes taken; all yeas, none opposed, no abstentions. Commissioner Mongillo moved to approve the eligibility list for an initial period of one year. Seconded by Commissioner Rodriguez. Votes taken; all yeas, none opposed, no abstentions. Commissioner Mongillo motioned to approve the list removal. Seconded by Commissioner Rodriguez. Votes taken; all yeas, none opposed, no abstentions. List removal approved.

Ms. Marcano then presented the list removal for an individual who requested to be removed from list #21-03 PC Support Technician when he was contacted for an interview. Commissioner Mongillo motioned to approve the list removal. Seconded by Commissioner Rodriguez. Votes taken; all yeas, none opposed, no abstentions. List removal approved.

Finally, Ms. Marcano presented the list removal for an individual from list #21-13 Police Officer Lateral, explaining that this person withdrew from the process. Commissioner Mongillo motioned to approve the list removal. Seconded by Commissioner Rodriguez. Votes taken; all yeas, none opposed, no abstentions. List removal approved.
