Mayor gave feedback and supportive; will present to Board of Alders (note to make sure to invite the CAC to the Board of Alders meeting). Will first present to leadership AS will reach out to Alder Crespo to ask for support as leaders to support. P Dunn - part of community advisers to the plan. Tasked with reimagining the cultural landscape of the arts & cultural sector in New Haven. Focus on neighborhoods, community, and the city. Allowed for deep thinking around arts & culture where everyone is invited to be around the table. Nice to see fresh faces and enjoyed the process that allowed for great conversations. Power mapping. Advisory group was a good representation of the city. Should we prerelease in draft form? LG recommends.

American Rescue Plan Grant-3 of the grants will be re-opened on August 17 and closing on September 30 for equity reasons. Process is challenging. Current offerings are Public Art, Outdoor Events/Festivals. Documents that are required via purchasing that are difficult for artists and cultural organizations to understand and relate. Many of the forms are geared towards for-profit companies and are outdated.

DACT in partnership with the Health Department is working with artists to assist with spreading the information on vaccinations. Billboards are being posted around the city.
