- B. DISCUSS THE H&H 2020 EXPERIENCE STUDY TO ESTABLISH THE INVESTMENT RATE OF RETURN AND TO ESTABLISH THE ACTUARILY DETERMINED EMPLOYER CONTRIBUTION (Continued)**

Trustee Gormany and Trustee Mayor Elicker suggest 7.25% Rate of Return instead of the 7% as H&H had suggested, and to also stay at 2% inflation rate, instead of 1%.

MOTION: Made by Trustee Zangari to accept the 7.25% recommendation and take a look back at it every two years.

DISCUSSION: Trustee Pietrosimone asks if the inflator rate should be the same for both CERF and P&F. Trustee Zangari disagrees. Trustee Graves asks if H&H agrees with the recommendation from the City. Richard Sych explains based off of the Experience Study, the Trustees would be accepting everything H&H recommended. Two alternatives: the inflator, and the investment return assumption. The support for 7.25% would need to be worked on with Derek and the City. Derek thinks collaboratively the board can make solid investment decisions to support 7.25 in the long term.

MOTION: Made by Trustee Zangari to accept the 7.25% and the recommendation that they increase the contribution to 15.9 million and go forward with that change and anything that H&H recommends.

DISCUSSION: Trustee Mayor Elicker explains the City is recommending to adopt most, but not all of H&H's recommendations. Trustee Graves needs clarity around the motion. Trustee Mayor Elicker recommends for the motion that we are reducing the rate of return from 7.75% to 7.25%, we are adopting the experience study recommendations, and keeping the inflator rate the same. Rich Sych states that is accurate.
