#### A. ROBBINS GELLER RUDMAN & DOWD LLP UPDATE

Pension Administrator, Leanna Ambersley, explained the report from Laura Stein: The fund has an estimated loss of \$28,157 in the BioMarin Pharmaceuticals, Inc. litigation matter. This loss is preliminary, and the case is at its very beginning stage. They do not recommend any action be taken at this time. In addition, Allied Nevada Gold Corp was highlighted on the October 2020 Settlement Report, indicating it may have a potential claim in that matter.

Jerome Sagnella and Leanna Ambersley update the Trustees about a potential cost to be split between both funds to cover the printing, folding, stuffing, and postage of welcome letters to be mailed to participants just before the pension portal goes live in the New Year.
