Research found that the Americans with Disabilities Act does not prohibit the listing of the disability applicants. Also, other lawyers in CT who represent pension funds agree that they follow the procedure that we follow, which is to list the applicants but then go into executive discussion to discuss the medical records. # C. UPDATE – IMPLEMENTATION OF FAVORABLE DISABILITY TAX RULING & AMENDMENT TO IRS-APPROVED CERF PLAN DOCUMENT

Re: Northern Trust, memo to unions for the MOUs, two newer unions: The Nurses and the Attorneys

Leanna Ambersley, Jerry Sagnella, and Jack Strother update the Trustees on the IRS favorable tax ruling; getting Northern Trust on board with implementing the ruling by issuing revised tax statements in regards to months that are already passed in 2020 and in regards to the whole retroactive 2019 so that members can reflect this on their amended tax returns and claims for refund.

Jack Strother discusses that they have been working with Labor Relations to get the language correct in the collective bargaining agreements. The IRS approved plan document goes off the language of those agreements and needs to be conformed as well. The omission of a single sentence in a couple of the bargaining agreements, and a simple language change to conform the agreements. All the unions are making that change. It emerged there are two newer unions (Nurses and Attorneys) who are not mentioned in the IRS approved plan document. Chair might wish to suggest a motion he be authorized to execute an amendment to include the Nurses union and the Attorneys union in the IRS approved plan document.
