ITEM 3: ADMINISTRATIVE MATTERS:

A. UPDATE ON IRS DISABILITY BENEFITS RULING

Carolyn Kone notified the Trustees that Attorney Strother spoke with the IRS and they told him that the division that sends out the letters is way behind. Nothing has changed since the last meeting. It seems to be favorable but because of the virus, there has been a delay in sending the actual formal notification. Trustee Sagnella states that this will allow employees, members of the CERF fund, who retire with a service-connected disability, to receive favorable tax treatment with 50% of their salary at the time of disability, exempt from taxes when they receive their pension. Police and fire already have this favorable tax treatment.

B. REVIEW OF THE BRENNER, SALTZMAN & WALLMAN CONTRACT
