We are pleased to provide the Fund with our Securities Litigation Report covering the securities class actions filed in the second half of 2019 (the "Period").

This Report summarizes the Fund's financial interest in all federal securities class actions filed during the Period that we have determined have strong merits based upon our comprehensive research process (see Chart 1). A total of 110 PSLRA securities class actions were filed in the U.S. during the Period (see Chart 2). These charts have been provided for informational purposes only.

The Fund's total estimated losses in actions with strong merits filed during the Period are approximately \$129,956. The loss amount is the estimated loss as limited by the PSLRA, which is not the same as your legally compensable damages, and unless otherwise indicated, is reported in U.S. dollars. Also, when reporting on the Fund's financial interest in a case involving a defendant company with securities traded on a non-U.S. exchange, we may exclude losses that are not actionable under U.S. law.

* Included in this chart are active cases filed during the Period, culled to highlight actions that we have determined have strong merits and warrant monitoring and/or were otherwise evaluated by Labaton Sucharow in the course of its comprehensive research process.

** The loss amounts listed in this chart were calculated using LIFO loss methodology and the Fund's trading data available to us. They are based upon static data assessed at the time of filing and may not represent any changes to the ongoing litigation (e.g., the impact of rulings on motions, changes to the relevant class period, the addition of securities, etc.). We have done our best to eliminate losses in cases that have been dismissed or have settled and are no longer applicable to this analysis. Any variance in the loss amounts reported in this chart, as compared to amounts found in prior reports, may be due to revised calculations using an updated 90-day mean trading price.
